

STOWLANGTOFT PARISH COUNCIL MEETING

**MONDAY 21 NOVEMBER 2022 AT 7.30 PM
THE 'COMMON ROOM', ST GEORGE'S RD, STOWLANGTOFT**

Present: Cllrs D'Lima (Chair), Cassidy, Cuff, Suggett and White. A Osman (clerk) was also in attendance along with 3 members of the public.

55 **Apologies for absence.** Cllr Catchpole sent his apologies which were accepted by the meeting.

56 **Declarations of Interest.** None declared.

57 **Minutes of the meeting held on 26 September 2022.** Cllr Cuff proposed that the minutes of the meeting held on 26 September, with agreed minor adjustments, be approved. Cllr Suggett seconded the motion, and it was carried unanimously.

The October planning meeting was cancelled due to no planning applications being received.

58 **Matters arising from the last meeting:**

Minute 42: 26 September 2022: Defibrillator. Cllr Suggett confirmed no further information had been received from the Benendon Charitable trust on the defibrillator and that any application to the Ridley Godfrey Foundation would require more detailed information than currently available. It was agreed to revisit this issue should an installation location be identified in the future.

Minute 47: 26 September 2022: Mobile Phone Mast. Cllr Cuff indicated that anecdotally potential income from mobile phone masts had significantly reduced over time. Agreed not to pursue this further.

Minute 52: 26 September 2022: Bin Stickers. The Clerk confirmed that quotes for A4 30mph bin stickers had been provided in his report.

Minute 52: 26 September 2022: 30mph repeater signs. The Clerk confirmed that the cost of a new 30mph repeater sign and post had been provided in his report.

Minute 52: 26 September 2022: Village White Gates. The Clerk reported that the village entrance white gates were painted in 2021 and that the village Cleansing Operative will monitor for future cleanliness.

Minute 52: 26 September 2022: Highways Defects. Cllr Cassidy confirmed that he had reported carriageway defects on the Suffolk Highways reporting tool and was challenging the negative response he had received back.

Minute 52: 26 September 2022: Village Name Sign. The Clerk confirmed the cost of a replacement village name sign in his report and indicated that the most economical way ahead was to replace individual letters that had become faded.

Minute 53: 26 September 2022: Dog Fouling. The Clerk indicated that dog fouling posters from Mid Suffolk District Council had been arranged to be delivered to Cllr Suggett for installation on the relevant public footpaths.

59. **County Councillors Report.** The Parish Council noted the contents of the report previously circulated.

60. **District Councillors Report.** The meeting noted the contents of the District Councillors reports that had been previously circulated.

61. **Clerk's report:**

Elections. A briefing on future Parish Council elections in May 2023 had been previously circulated in the clerk's report. It was agreed to add this issue to the January 2023 meeting agenda when further information was available for Mid Suffolk District Council.

Tables. It was agreed to purchase 2 foldable tables for use at Parish Council Meetings.
The Clerk was to purchase.

62. **St George's Church.** Mr Davies provided a resume of the significant work he had done to restart the clock and indicated that it was now running with the regulator disabled. This meant it would gradually lose time, but this could be monitored and adjusted pending the visit of Clockwise Restoration to provide a quote for permanent fix. The meeting also noted that the condition of the clock face was poor and required cleaning.

63. **Finance:**

Finance Report. Cllrs noted the financial report (current bank balance of £4926,67 and the projected outturn at the end of the FY of £2,350) and approved the requests for payment.
Cllr Suggett agreed to authorise the payments.

Budget FY23/24. Cllr Cuff proposed that the Parish Council budget for FY23/24, circulated prior to the meeting, be approved subject to the budget for village improvements increasing to £500. The budget assumed no change to the precept level. Cllr Suggett seconded the motion, and it was carried unanimously.

Locality Fund Bids. The meeting agreed to seek county and district councillor locality funding for 30mph bin stickers (4 packs), to augment village speed management approach, and to relocate the VAS at the eastern end of The Street which suffered from tree screening. **The Clerk was to email county and district councillors to seek locality funding. Cllrs Cuff and Cassidy agreed to review the location for the new VAS post and to discuss with local landowner prior to the next meeting.**

64. **Planning matters.** No new planning applications. The meeting noted that DC/22/01884 Full Application - Change of Use to Vehicle Servicing, Maintenance and Repair Garage (Use Class B2) including external alterations at The Pine House Company, Ixworth Road, Stowlangtoft, Bury St Edmunds Suffolk IP31 3JS, had been granted on 7 October.

65. **Highways matters.** The meeting noted an update on likely timelines for replacement of the A1088 Bridge (planned for spring 2024) and the response from Suffolk County Council to the Parish Councils note of concern over increased traffic through the village that had been previously circulated.

66. **Correspondence.** Cllr D'Lima reported he had completed mandatory reporting to the Pensions Regulator over the Parish Council's pension liabilities.

67. **Councillors' Forum:**

Frequency of Meetings. It was agreed to expand the remit of bi-monthly planning meetings to include consideration of urgent items. This approach would be kept under review.

Village Planters. It was agreed to review how village planters were maintained and to finalise arrangements at a future meeting. Cllr Cassidy reported that Mid Suffolk District Council had agreed to provide wildflower seeds for Kiln Lane by the bench and the 'orchard' by the recycling bin.

ANPR Camera Project. The meeting noted the Suffolk ANPR Camera Project.

68 **Public Forum.** A member of the public highlighted issues with visibility of the village planters at night. It was agreed to consider this as part of the review of how these were maintained covered in para 67.

69 **Date of next meeting:** The next meeting to discuss the relocation of the eastern VAS will be held on Monday 19 December 2022 at 7.30pm in The Common Room, St Georges Street, Stowlangtoft.

The meeting concluded at 8.55pm.

Full Council – 20th October – GLI Motion

We submitted a motion calling for Suffolk County Council to reject the idea of an “Anti-Growth Coalition”. The term, coined by former PM Liz Truss, suggests anyone who criticised the government’s

economic policy was part of a coordinated group against growing our economy. Of course, since then things have quickly moved on and we now have a new Prime Minister with new priorities.

Our Group wanted to debate the issues – including the view that growth should consider social responsibilities, community voices, sound financial policy, and environmental limits, something we believed this government was not adhering to. A useful debate was had.

SCC Cabinet Meeting – 11th October

The Cabinet met for the first time since the summer political recess. The Cabinet agreed to spend £2m on new care provision for Children and Young People in Felixstowe. In addition, SEND services received £10m to provide more specialist units in Suffolk. The opposition supported this spending, as we want to remove the pattern of families travelling cross-county to access educational support.

The Suffolk Local Access Forum submitted their annual report, which included their concerns about Sizewell C and its effect on green networks and Rights of Way. We continue to voice concerns over the effects of nuclear power on our coastal landscape and biodiversity.

In addition, the Cabinet endorsed Transport East's new 2050 strategy, which focusses more on green travel and linking rural communities to local economies. Our Group recognises the importance of connecting isolated residents for both profession and pleasure, and we will ensure SCC adopts all priorities into its own policy. This includes local bus provision which is a really difficult issue for residents affected by recent timetable reductions.

MSDC Meeting (October).

The performance of the £49 Million retail property portfolio was reported. In 2021/22 a yield of 3.5% was made. Questions were raised as to the effect of the current economic conditions on its future performance.

Within the overview committee it was resolved that Mid Suffolk Overview and Scrutiny Committee recommend to Mid Suffolk Cabinet that, as part of the development of the electric bus project, local consultations to elicit unmet transport needs should be carried out – one covering an urban area and one covering a rural area.

Joint Local Development scheme 2022-25 was discussed and adopted.

Questions were asked about what provisions were being made to continue the support to our Ukrainian guests.

Planning

Continuing to push implementation of the Heath Road development.

Supported the Thurston Parish Council position on the Linden Homes phase2 application with safeguards for the established woodland of Lady Green Plantation for our community.

DC/22/ 00398 Follow up meeting postponed so call in still has not happened.

EN/22/00335, EN/22/00492 Barrell's Road, our MSDC enforcement officer has confirmed that there have been breaches of the planning approval. The next steps are awaited. No word as yet on what changes are to be made following the planning peer review or our councils request for leave to appeal the outcome of the Judicial Review.

Ben Wragge 33 acres

Members of West Suffolk District Council strongly suggest that MSDC creates an out of area CIL project. Explore ways of progressing the funding of this project. Our electoral officer requires cabinet support before researching how to change our Parish/District boundary. Neighbouring residents feedback/meeting planned with their views to be given to the project team.

Gateway 14

Site creation is on track with 'The Range' distribution warehouse schedule to open before the end of 2023 which will provide many new career opportunities for our residents.

Environmental/biodiversity news

Suffolk Public Sector Leaders (SPSL) unanimously agreed funding today to create a new Fuel Poverty Retrofit Team, helping those most affected by the rising cost-of-living. It will be part of the Warm Homes Suffolk scheme, which was jointly established by Suffolk County Council, Babergh and Mid Suffolk Councils, West Suffolk Council, East Suffolk Council and Ipswich Borough Council in 2021. The scheme is a source of expert advice on reducing energy bills and in identifying benefits that residents may be entitled to. This winter, Warm Homes Suffolk extends its support further with the creation of a Fuel Poverty Retrofit Team: supporting residents in energy-inefficient homes, struggling most to afford rising energy bills. More than 62,000 properties in the county are thought to have the worst Energy Performance Certificates (EPC) of E, F or G. And an estimated 28% of homes - 95,000 households – are in fuel poverty, almost double the number in 2019. SPSL today pledged £366,000 to create the new team to tackle the challenges, with a further £390,000 of funding underwritten. Measures could include the installation of insulation, fitting air source heat pumps and replacing single glazing.
